With nearly 20 years of experience, including over a decade at North Central College, I serve as a Principal Lecturer in Communication and Media Studies and Faculty Director for the Center for the Advancement of Faculty Excellence (CAFÉ). I've been recognized with awards for both teaching and mentoring, reflecting a deep commitment to student development. I also direct the campus Speaking Center and coordinate First-Year Speaking, where I support students in building communication confidence and finding their voice early in their college experience. As a former Provost Faculty Fellow, I explored ways to help students bridge classroom learning with real-world career skills. Beyond campus, I serve as Vice President of the Board of Education for Indian Prairie School District 204, where I work to strengthen public education and cultivate community partnerships.
