INSTRUCTIONS

Please read these instructions carefully and enter ALL person required on the front of this form.

Attending a college/university: Persons can only be included as attending college who will be going to college between July 1, 2018 and June 30, 2019. Include only students enrolling (or who are accepted for enrollment) for at least 6 credit hours in at least one term. If the school uses clock hours, include only students attending at least 12 clock hours per week. The student must be working towards a degree or certificate leading to a recognized education credential at a college that is eligible to participate in any of the federal student aid programs.

Please NOTE: Parents cannot be included in the number in college.

Definition of Support: The word "support" means one-half of all basic maintenance costs for the entire I2-month period (July 1, 2018 through June 30, 2019). This could be full support for at least 6 months or half-support for I2 months. Items considered as support include, but are not limited to, money, gifts, loans, housing, food, clothes, car, medical and dental care, payment of college costs, etc.

Number of Household Members: List below the people in the parents' household. Include:

- The student.
- The parents (including a stepparent) even if the student doesn't live with the parents.
- The parents' other children if the parents will provide more than half of the children's support from July 1, 2018, through June 30, 2019, or if the other children would be required to provide parental information if they were completing a FAFSA for 2018-19. Include children who meet either of these standards even if the children do not live with the parents.
- Other people if they now live with the parents and the parents provide more than half of the other people's support and will continue to provide more than half of their support through June 30, 2019.

Number in College: Please include in the space below information about any household member who is, or will be, enrolled at least half time in a degree, diploma, or certificate program at an eligible postsecondary educational institution any time between July 1, 2018, and June 30, 2019, include the name of the college.
