Dear Student:

We anticipate that you will be eligible to receive an Illinois Student Assistance Commission (ISAC) Monetary Award Program Grant (MAP Grant) for the 2021-22 academic year. Before we can determine if you are eligible for MAP funds, your Illinois residency must be verified. ISAC rules state that a self-supporting student is considered a resident of Illinois if he/she meets the following criteria:

"An independent student is a resident of Illinois if the applicant physically resides within the State of Illinois (at the time of Free Application Federal Student Aid application) and has so resided for a period of twelve continuous, full months immediately prior to the start of the academic year for which assistance is requested and Illinois is his or her true, fixed and permanent home."

## This means that you must have resided in Illinois since BEFORE August 25, 2020

- □ Statement of benefits from the Social Security Administration for calendar year <u>2019</u>
- □ Illinois voter's registration card issued PRIOR to August 25, 2020
- □ Property tax bill issued PRIOR to August 25, 2020
