Summer Session: International undergraduate students are not required to attend summer session. If an international student decides to do so, they will pay tuition based on the number of credits taken. This tuition is in addition to the amount shown above for the academic year.

Family Members: International students should calculate an additional \$5,000 per year in living expenses for a spouse and \$2,500 per year for each dependent child. Family members accompanying students in F-1 status will receive I-20s for F-2 status. F-2 dependents will not be allowed to work in any type of employment.

Important Note: The expenses listed above are only estimates and actual costs may be higher. North Central reserves the right to make changes to tuition, fees, and other charges at any time. Applicants/Sponsors should expect and plan for an annual increase, of up to 5%, in tuition and fees each academic year.

Scholarships as Taxable Income: Every international student is required to file a tax return as a condition of their visa, but not everyone will pay taxes to the U.S. government. Scholarships from North Central may have tax implications for international students as determined by the Internal Revenue Service (IRS) of the United States. The U.S. government considers any amount of scholarship received **that is in excess of tuition** as taxable income.
