Course Description:

This course explores the post Economic crisis of Greece and its geopolitical role in the Southeast European Union. It will provide a broad analysis of the regional political, social, legal and economic dynamics of the region as they relate to Greece and its neighbors. The seminar includes topics such Culture of Greece (Historical foundations, aesthetics, etc.), the role of Greece in the regional economy, the impact of the financial crises on society, the role of the European Union on Greece and the crisis, Monetary Union, immigration and urbanization.

Enrollment Deadline: November 1, 2023

(or before, if course capacity is met).

Center for Global Education (CGE) Registration:

- **November 1, 2023:** Students enrolled in a CDCA will begin the registration process, be charged a non-refundable \$40 registration fee, and prompted to pay the non-refundable \$500 program fee deposit, through the Center for Global Education.
- **January 19, 2024:** Proof of a valid passport is due. *(Current passports must be valid through November 2024 for May term travel, six (6) months past your return travel date.)*

Payment Deadlines:
